Count 1

Charge: Murder - 1st Degree - While Committing Child Abuse with Past Pattern of Child Abuse
In Violation of: 609.185 Subd. (a)(5)
Penalty: Life imprisonment without possibility of release

That the above-named defendant, Robert John Kaiser, then and there being, did wrongfully, unlawfully, and feloniously cause the death of a minor, to wit: W.J.P.-K., DOB: 6-24-14, while committing child abuse, when the defendant has engaged in a past pattern of child abuse upon a child and the death occurs under circumstances manifesting an extreme indifference to human life.

Count 2

Charge: Murder - 2nd Degree - Without Intent - While Committing a Felony
In Violation of: 609.19 Subd. 2(1)
Penalty: Up to 40 years in prison

That the defendant, Robert John Kaiser, then and there being did wrongfully, unlawfully, and feloniously, cause the death of a human being, to wit: W.J.P.-K., DOB: 6-24-14, without intent to effect the death of W.J.P.-K., while committing or attempting to commit a felony offense, to wit: Assault in the Third Degree.


